- 5. In super structure brick work will be laid in cement sand mortar 1:4 for 9" thick walls
- Plastering of both internal and external walls shall be done in cement sand mortar of ratio 1:4.
- 7. Hardstanding Flooring. Earth filling inside foundation shall be leveled and compacted with watering and rolling in layers not exceeding 250mm over which a 100mm thick PCC sub-base 1:4:8 with 40mm graded stone aggregate will be provided. Thereafter, a 80mm thick screed bed with cement sand mortar of 1:2:4 shall be provided. Flooring shall be done over this surface using crusher
- 8. Existing old material be used only if it has a strength to work for long time for wall repair.
- Construction should be as per drawing given.

Pipe will be grouted 2 Ft under ground level and 12 Ft height above ground level. All pipes should be of ISI mark.
- 11. Colour of Galvanised sheet be specified by school authorities and 2'-0" to be kept outside the dice area. Thickness of Galvanised sheet will be min 0.5 mm or as specified by school.
- 12. Ultra Tech/Gujrat Ambuja cement of 53 OPC or higher grade shall only be used.
- Samples of all fitment items will be provided and approved before commencement of work.
- 14. The structure shall be constructed strictly as directed and specified as per pathways. However, there shall not be any change in the scope of work from what has been mentioned in this document.
- 15. In case of any ambiguity on any aspect related to the construction of the structure, The National Building Code shall be taken as the guiding document.
