2. The Skilled/Semi Skilled persons in the following categories will be provided:-
(a) Safai Karamchari (b) Plumber (c) Carpenter (d) Electrician (e) Welder (f) MTS
3. The above category persons so provided should have the following eligibility criteria:-
(a) In the age group of 30 to 50 years preferably Ex-Servicemen.
(b) In case persons are not ESM, they should have minimum of two years experience in the nature of work.
(c) Physically and medically fit to perform the specific duties effectively (Medical Certificate will be given before employment).
(d) They should be well behaved and smartly dressed. They should be in possession of minimum 2 sets of uniform as prescribed and the same to be provided by the contractor/agency.
(e) The uniform will be approved by the School Authorities.
(f) All persons should be trained in use of Fire Equipments and First Aid.
(g) Trained in rescue operations in case of natural calamity/accident.
4. I/We will understand that -
(a) The above category persons may be increased/decreased by the School Management according to the requirement.
(b) I/we will not permit the persons to perform the duties beyond 8 hours in a day.
(c) Those who are found unsuitable for duties by the School Management will be changed by the firm/agency providing house keeping services.
(d) They will be responsible for day to day maintenance of the school and its premises.
(e) The persons so provided will work in the supervision of the supervisor who will work under Adm Supervisor of the school.
(f) No item(s) from the school premises will be taken out of the gate without proper gate pass/brought in the school premises without the permission of the school authorities.
(g) The Firm/Agency is registered with the Govt (Director General of Resettlement) of the concerned State and has the EPF and ESIC Nos allotted (Copies of the Registration of firm, EPF, ESIC, GST No & PAN No to be attached duly self attested).
(h) Providing EPF and ESIC cover etc as applicable will be the responsibility of firm/agency.
5. "Commercial Bids" of only agency/vendors will be opened those who qualify the terms and conditions of "Technical Bid". **Technical and Commercial Bids to be submitted in separate envelopes duly marked on the top as "TECHNICAL BID" and "COMMERCIAL BID" separately.** Both the envelopes to be put in a large envelop duly marked on the top as "TENDER FORM FOR PROVIDING SECURITY SERVICES". The tenders are to be deposited in the tender box kept at reception counter at Army Public School, Ambala Cantt (Main Wing).
6. Further it is certified that the above mentioned conditions are acceptable to us and will be complied with.
7. Last date of receipt of sealed tenders duly completed is 17 Jul 2024 by 1300h and the tender will be opened on 18 Jul 2024 at 1100 hrs.

 - (f) The person does not become an employee of the school by virtue of his/her deployment in the campus.
 - (g) Onward and before the commencement of contract, a sum of Rs. 50,000/- will be deposited with the school as refundable security.
4. Earnest money Rs. 10,000/- to be deposited with school through DD/Cash in favour of Principal Army Public School, Ambala cantt. In case the L1 agency does not come forward for negotiation, the earnest money of Rs. 10,000/- will be forfeited.
5. After the allotment of contract, in case 'Agency' withdraws within three months, the security deposit of Rs. 50,000/- will stand forfeited.
6. "Commercial Bid" of only vendor will be opened those who qualify the terms and conditions of 'Technical Bid'
7. The management reserves the right to reject any tender without assigning any reason and decision of this institution will be final and binding
